The United Republic of Tanzania has received financing from the African Development Bank toward the cost of Dodoma Resilient and Sustainable Water Development and Sanitation Program Phase I and intends to apply part of the agreed amount for this loan to payments under the contract for **Construction of Farkwa Dam and Access Road**.

2. The Tanzania Ministry of Water intends to prequalify contractors for the **Construction of Farkwa Dam and Access Road**. The assignment involves construction of the Farkwa Dam, to be located downstream of the confluence of Bubu and Mkinki rivers in Mombose and Bubutole Villages of Farkwa Ward, Chemba District, Dodoma Region, is approximately 130 kilometers north of Dodoma on the road to Kondoa District. The dam includes a 32 m high composite roller compacted concrete (RCC) and earthfill Main Dam with intake, outlet works, and spillway (FSL 1,110m), a 15 m high earthfill Saddle Dam, and associated site access roads totaling 12 km. The dam is designed to provide water for domestic use, irrigation, and livestock purposes. It is expected invitation for Bids from the Prequalified bidders will be made in July 2024.

3. Prequalification will be conducted through the procedures as specified in the African Development Bank's Procurement Policy for Bank Group Funded Operations, dated October 2015 ("Procurement Framework"), and is open to all eligible Applicants as defined in the Procurement Framework.

4. Interested eligible Applicants may obtain further information from the Ministry of Water at the address below during office hours, from 8:00 to 15:30 hours, Monday to Friday inclusive, except on public holidays. A complete set of prequalification documents in English language may be obtained free of charge by interested Applicants upon the submission of a written application to the address below.
