THE CONSTITUTION OF THE UNITED REPUBLIC OF TANZANIA, 1977

(CAP.2)

**INSTRUMENT**

---

*(Made under Article 55)*

---

**WHEREAS**, Article 55 of the Constitution of the United Republic of Tanzania, 1977, hereinafter referred to as “the Constitution”, empowers the President to establish and disestablish such offices of Ministers in the Government of the United Republic as he may, by Instrument under his hand and the Public Seal, determine;

**AND WHEREAS**, consequent upon the General Elections held on the 28<sup>th</sup> day of October, 2020, the results of which were declared by the National Electoral Commission on the 30<sup>th</sup> day of October, 2020, I am minded to disestablish the Offices of Ministers so previously promulgated and to establish *in lieu* of them, the Offices of Ministers specified in the Schedule to this Instrument;

**NOW THEREFORE**, in the exercise of the powers conferred on the President by Article 55 of the Constitution and all powers enabling the President in that behalf, I, **SAMIA SULUHU HASSAN**, the President of the United Republic of Tanzania, do hereby disestablish all the Offices of Ministers specified in all Instruments previously promulgated and subsisting immediately before the coming into operation of this Instrument and establish *in lieu* of them, the Offices of Ministers specified in the Schedule to this

Instrument.

This Instrument shall be deemed to have come into operation on the 5<sup>th</sup> day of November, 2020.
