Project measures:

The Simiyu Climate Resilience Project (SCRP) is financed by the Green Climate Fund (GCF), the German Government through KfW and the Government of Tanzania. The Ministry of Water (MoW) is the Project Executing Agency (PEA) and is steering and overseeing the project.

The objective of the SCRP is to increase the climate resilience of rural and urban households, particularly small-scale farmers and women living in the Simiyu Region, and to improve policies and regulations for cross-sectoral action towards climate change adaptation.

Requested Works:

The Works Contract (WC) 2 of bulk water supply system consists of the following:

• Transmission mains pipeline of about 130km ranging from 200 mm to 900 mm Diameter steel.

• Water storage reservoirs (Reinforced Concrete) of capacity ranging from 500 m3 to 15,000 m3.

• Pumping Station with sump capacity of 6,000m3.

• Distribution Network of between 160 and 320 km in Three (3) towns (Nyashimo, Bariadi & Lagangabilili) and their respective peri-urban areas, diameter ranging from 50 mm to 450 mm (HDPE and Steel)

- Installation of Bulk Water Meters and Pressure Reducing Valves.
- Reconnection of existing house connection.
- Main Road crossing with trenchless technology,
- Construction of Pipe Bridges,
- Connection to HV Power Supply.

WC2 is intended to be based on the FIDIC Conditions of Contract for Building and Engineering Works designed by the Employer (Pink Book). Expected Construction Period is 24 Months + 12 Months Defect Notification Period

Companies with qualified personnel, appropriate facilities and experience in the execution of comparable projects may request additional information to prepare pre-qualification documents for the above contract Pre-qualification documents will be available in English language at the address below and are free of charge. The documents must be completed and submitted in English language.
