Reference: International open Tender for Consultancy Services for Elaboration of a Feasibility Study aiming to prepare the Climate adapted urban Infrastructure and Integrated Water Resources Management (IWRM) Program for Tunduma and Vwawa-Mlowo towns in Tanzania.

Requested Consulting Services:

Tanzania is among the developing countries whose social and economic welfare is already vulnerable to the negative effects of climate change. In addition, rapid urbanization is a major development challenge, especially for fast growing towns and cities.

The growing and competing demand on water use is increasing due to population, social-economic utility, hydropower and agricultural expansion. The Government of Tanzania developed the National Water Policy (NAWAPO) in 2002 (reviewed in 2020) and is implementing the Water Sector Development Programme (WSDP) to enhance the implementation of the NAWAPO.

Based on a Scoping Study (2017) the rapidly growing neighbouring towns Tunduma and Vwawa-Mlowo in south-west Tanzania were selected for a first investment under the "Climate Adapted Urban Infrastructure and Integrated Water Resources Management Program". This program aims to provide improved water security to the population of these two towns of major importance for regional integration and economic development.

The program shall follow an integrated and holistic multi-sector approach and shall encompass preparatory measures to support the sustainable management of water resources, physical infrastructure to ensure water supply and sanitation services, stormwater management and flood control and possibly other municipal services (such as solid waste collection and disposal) as well as accompanying measures to ensure the sustainable operation of the physical infrastructure.

In this context the Ministry of Water (MoW) – with financial assistance from the German Government through KfW Entwicklungsbank and with a maximum gross budget of EUR 850,000.00 – now intends to engage a Consultant for the elaboration of a Feasibility Study, which shall be carried out in a sequence of three steps:

- 1) Elaboration / outline of the details of the "integrated and holistic approach" to be applied for the Program
- 2) Applying the agreed "integrated and holistic approach" to the two towns Tunduma and Vwawa-Mlowo and identifying individual Projects for the two towns including respective measures/packages
- 3) Preparation of selected and confirmed individual Projects for both towns on Feasibility and Preliminary Design level

The scope of main Consulting Services under this Feasibility Study will comprise but may not be limited to the following:

- Review and update of the Detailed Studies of 2011 for the water supply and sanitation components for Tunduma and Vwawa-Mlowo towns
- Assessment of vulnerability of the water resources and catchment areas and suitable integration of protection measures
- Assessment of the need for development/improvement of land use and town plans
- Assessment of the need for institutional strengthening and capacity building with regard to O&M of selected priority measures of related sectors
- Assessment of support in implementation of the program (multisectoral approach)
- Assessment of Risks to program implementation as well as O&M and mitigation measures
- Analysis of Target Groups and Stakeholders
- Gender Analysis

• Elaboration of a Preliminary Environmental and Social Management Framework (ESMF)

The prequalification of experienced Consultants will follow the latest version of KfW <u>"Guidelines for the Procurement of Consulting Services, Works, Plant, Goods and Non-Consulting Services in Financial Cooperation with Partner Countries</u>" (please refer to homepage of KfW Development Bank <u>www.kfw-entwicklungsbank.de</u>).

It is foreseen to assign an independent consultant firm with proven international experience in the urban infrastructure (especially the water and sanitation) as well as the IWRM sector and having a regional experience record. In case of an international lead consultant it is recommended to associate with a local consulting firm. The minimum annual turnover of the consultant is fixed at EURO 10.0 million, with – in case of a Joint Venture – the minimum annual turnover of the lead consultant being EUR 7.0 million.
